PROGRAM FEATURES

- Full property coverage tailored for unique needs of Greek housing
- Guaranteed replacement cost
- Law & ordinance: required upgrades due to new laws
- Business income & extra expense
- Contents / business personal property
- Major systems coverage (HVAC, boiler)
- Bi-annual inspections
- Multiple deductible options



KEY DEADLINES

- Ongoing: Any change to your facility that may affect your coverage, let Trude Smouse know (with a cc to Anne Emmerth)
 - Business income coverage
 - Contents coverage
 - Mortgage holders / name of bank
 - New names / contact info for key volunteers
- By February 1:
 - Email from Anne Emmerth describing deadlines and renewal cycle
- By February 7:
 - Contact Trude Smouse about any changes to your coverage (e.g., increased deductible, name of mortgage holder)

KEY DEADLINES

- First week in March: Property insurance premium bill will be sent out from Beta Theta Pi.
 - Via email
 - Will go to HC president, HC treasurer, insurance contact
 - Copy of Evidence of Property Insurance (EPI) certificate & detailed memo about coverage
- March 31: Premium payments due to Beta.
 - EPIs for mortgage holders won't be send until you pay your premium.
- April 1: Insurance renewal year begins.
- Monthly emails are sent to all house corporations with a balance with General Fraternity

 - Estimate 3% - 5% for budgeting purposes
